AMANDA GILROY is Director of Studies, MA Romantic Histories at University of Groningen. Her publications include *Romantic Geographies: Discourses of Travel, 1775-1844*, and *Epistolary Histories: Letters, Fiction, Culture* (co-edited with Wil Verhoeven). She is working on an edition of Charlotte Lennox's *The Female Quixote* and a book entitled *Equiculture: Gender, Nationality, Equestrianism, and Eighteenth-Century British Culture*.

WIL VERHOEVEN is Professor of American Culture and Cultural Theory and Director of the American Studies Program at University of Groningen. He is co-editor of *The Charles Brockden Brown Electronic Archive and Scholarly Edition* and general editor of *Ten Anti-Jacobin Novels*. His recent publications include *Revolutionary Histories: Transatlantic Cultural Nationalism, 1775-1815*; *Revolutions and Watersheds: Transatlantic Dialogues, 1775-1815* with Beth Dolan Kautz; and *Epistolary Histories: Letters, Fiction, Culture* with Amanda Gilroy. He is working on an edition of George Walker's *The Vagabond* and *Contested Lands: Radicalism, Emigration, and the 1790s American Travel Narrative*.

CLAUDIA L. JOHNSON is Professor of English at Princeton University and author of *Jane Austen: Women, Politics, and the Novel* and *Equivocal Beings: Politics, Gender, and Sentimentality in the 1790s*. She is currently finishing *Jane Austen's Cults and Cultures* and working on *Raising the Novel*, from which the present essay is drawn.

ROBERT MILES is Professor of English Studies at the University of Stirling. His books include *Gothic Writing 1750-1820: A Genealogy*; *Ann Radcliffe: the Great Enchantress*; and *Gothic Documents 1700-1820: A Sourcebook*, edited with E.J. Clery. His current project is a book provisionally titled *Romantic Misfits*. His *Jane Austen*, in the *Writers and their Works* series, will appear in 2002.

CLIFFORD SISKIN is the A.C. Bradley Professor of English Literature at the University of Glasgow. His publications include *The Historicity of Romantic Discourse* and *The Work of Writing: Literature and Social Change in Britain 1700-1830*. He is now asking when and how an eighteenth-century genre became the thing that we love to blame: THE SYSTEM.

JACQUELINE M. LABBE is a Reader in Nineteenth-Century Poetry at the University of Warwick, UK. She is the author of *The Romantic Paradox: Love, Violence, and the Uses of Romance, 1760-1830* and editor of a new edition of *The Old Manor House*. She is currently at work on a book about Charlotte Smith's poetry.

MICHAEL GAMER is Assistant Professor at the University of Pennsylvania. He is author of *Romanticism and the Gothic: Genre, Reception, and Canon Formation* and has recently completed a new edition of Horace Walpole's *The Castle of Otranto* and, with Jeffrey Cox, *Romantic Theater: An Anthology*. He is currently at work on a book manuscript, *Novel Realisms*.

MARILYN BUTLER, Rector of Exeter College, Oxford, is author of such books on Romantic-period literature as *Jane Austen and the War of Ideas* and *Romantics, Rebels and Reactionaries*. She has edited works by Wollstonecraft and Austen. Her next major publication will be the *Collected Works of Edgeworth*, of which she is the General Editor.

SIMON EDWARDS is Principal Lecturer in English at University at Surry Roehampton. He has published on Dickens, Scott, and aspects of the European historical novel. He has taught in the US, Japan, and throughout Europe.
