### ELECTION OF OFFICERS AND DIRECTORS AT 25TH ANNUAL MEETING

The Twenty-Fifth Annual Meeting of the American Diabetes Association was held in New York City June 19-20, 1965. At the Business Session on June 20, Thaddeus S. Danowski, M.D., Pittsburgh, was elected President for the 1965-66 organizational year, to succeed Rachmiel Levine, M.D., of New York.

Laurentius O. Underdahl, M.D., Rochester, Minnesota, was chosen President-Elect, and Edwin W. Gates, M.D., Niagara Falls, Vice President. Joseph H. Crampton, M.D., Seattle, was re-elected Secretary, and George J. Hamwi, M.D., Columbus, Ohio, was elected Treasurer.

Dr. Danowski served previously as President-Elect, Vice President, and as a Director since 1957; for a number of years he has chaired the Committee on Professional Education. Dr. Underdahl was Vice President (1964-65) and Secretary (1961-62 through 1963-64). Dr. Gates was Treasurer (1961-62 through 1964-65), and Dr. Hamwi a Director since 1960.

The members of the Board of Directors are listed on the masthead above. For the three-year term expiring in 1968, the following were re-elected Directors: W. Wallace Dyer, M.D., Philadelphia; Frederick C. Goetz, M.D., Minneapolis; Laurance W. Kinsell, M.D., Oakland; and Edwin L. Rippy, M.D., Dallas. Harvey C. Knowles, Jr., M.D., Cincinnati, was elected to fill the term expiring in 1966 of Dr. Hamwi, who was elected Treasurer.

William R. Jordan, M.D., Richmond, and William R. Kirtley, M.D., Indianapolis, were re-elected Chairman and Vice Chairman, respectively, of the Assembly of State Coordinators and Affiliate Delegates. Both Dr. Jordan and Dr. Kirtley by reason of holding the above-mentioned offices were re-elected to the Board of Directors for a one-year term. At the annual session of the Assembly of State Coordinators and Affiliate Delegates, James B. Hurd, M.D., Chicago, was proposed by the Assembly to serve as a Director for a three-year term expiring in 1968, and was elected at the Annual Business Meeting of the Association. He succeeds Maurice Protas, M.D., of Washington, D.C.

## ESTABLISHMENT OF NEW RESEARCH SUPPORT PROGRAM

The American Diabetes Association is pleased to announce a new research support program beginning July 1, 1966. This program is designed to assist exceptionally promising young investigators in their transition to the level of established investigators and is being designated as *The Research and Development Award Program of the American Diabetes Association*. To qualify, applicants should have had three years of relevant research experience with publications; residency training is not considered the equivalent of research experience. Applicants must be members of University-affiliated institutions within the United States and U.S. Possessions. Complete details will be published in the August issue of this Journal.

With initiation of the new research support program, the present Research Fellowship Program will terminate on June 30, 1966.

## 1966 LILLY AWARD

The tenth Lilly Award will be given at the Twenty-sixth Annual Meeting of the American Diabetes Association at the La Salle Hotel in Chicago on June 25-26, 1966. The following stipulations govern the contest for this annual award, which is supported by Eli Lilly and Company and consists of \$1,000 and a medal.

*Purpose:* To recognize demonstrated research in the field of diabetes, taking into consideration independence of thought and originality.

*Eligibility:* Any investigator in an appropriate field of work, closely related to diabetes, who is less than forty years of age on January 1 of the year in which the award is made. The research will not necessarily be judged in comparison to the work of more mature and experienced workers. The candidate should be a resident of the United States or Canada.

*Nominations:* Nominations for the award will be solicited from the Members of the American Diabetes Association. Such nominations will be requested by repeated notices to be published in DIABETES. Names of nominees will be sent to the Chairman of the Committee on Scientific Awards and must be received before December 1 of the year preceding the award. The nomination should be accompanied by full information concerning the nominee's personality, training and research work. Six copies of each item should be submitted. No member may send in more than one nomination. A list of the nominee's publications, if any, and six copies of the

publication or manuscript for which the award is to be given should also accompany the nomination. At the discretion of the Committee on Scientific Awards, the award may be given for work published during the year prior to December 1 of the year preceding the award. The nominee should be actively engaged at that time in the line of research for which the award is to be made.

*Announcement:* The name of the winner will be announced in DIABETES. The winner will be invited to present a paper on his work at the Annual Meeting. Papers considered for the award must be submitted with the idea that they will be published in whole or in part in DIABETES if found acceptable to the Editor and/or Editorial Board. If the Committee should decide that no outstanding work has been presented for this consideration, the award will not be made.

*Award:* In addition to the monetary award and medal, traveling expenses will be given to make it possible for the recipient to receive his award in person at the Annual Meeting.

Following the usual practice of observing official Diabetes Week the week before Thanksgiving, Diabetes Week this year will be November 14-20. Affiliate Associations and Committees on Diabetes of County and State Medical Societies are urged to note this date in making plans for their Public Education and Detection programs.

### SYMPOSIUM ON AUTOMATION

The 1965 Technicon Symposium on Automation in Analytical Chemistry will be held at the Statler-Hilton Hotel in New York, September 8-10. Scientific reports on recent significant developments in the automation of diagnostic and clinical procedures will be presented by physicians, biochemists, pathologists, and researchers from this country and abroad. Reports will include significant progress in automation of multiple analysis and health screening, in vivo renal physiology investigation, serum lipid determination, biochemical investigations of enzymes, clinical enzymology and immunology and hematology.
