The American Meteorological Society was organized for "The Advancement and diffusion of knowledge of meteorology, including climatology, and the development of its application to public health, agriculture, engineering, transportation by land and inland waterways, navigation of the air and oceans, and other forms of industry and commerce." Any person, corporation or other organization interested in these aims may be elected to membership. The organization of the Society took place in affiliation with the American Association for the Advancement of Science at St. Louis, Mo., Dec. 29, 1919, and its incorporation, at Washington, D. C., Jan. 21, 1920. The work of the Society is carried on by the **BULLETIN**, by papers and discussions at meetings of the Society, and by correspondence. There is close co-operation between the Society and the official weather services of the Americas.

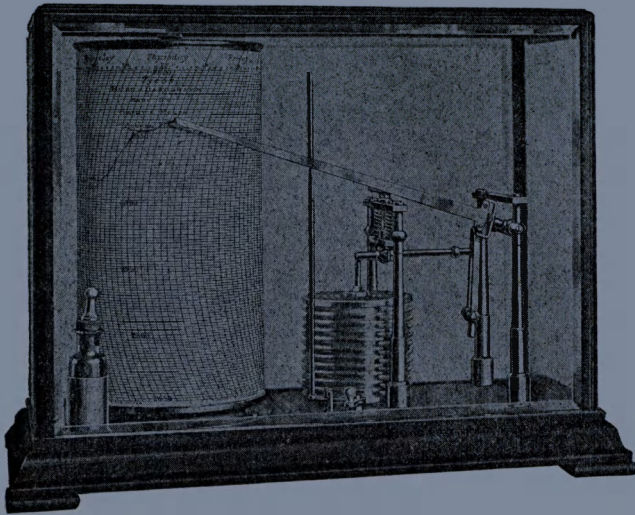
Membership Dues and Privileges
