To expedite the process, an electronic submission and review process is employed. To preserve anonymity, put the cover page and the remainder of the document in separate Microsoft® Word files. In the case of manuscripts reporting on field surveys or experiments, the instrument (questionnaire, case, interview plan, or the like) should also be submitted in a separate file, with identity of the author(s) deleted. Beginning July 1, new manuscripts must be submitted through the Manuscript Submission and Peer Review System for *AJPT*, located at <http://ajpt.allentrack.net>. The site contains detailed instructions regarding the preparation of files for submission. All inquiries regarding revisions of manuscripts originally submitted before July 1, 2011 should be emailed to the incoming editor, W. Robert Knechel at AJPT@warrington.ufl.edu. A nonrefundable submission fee in U.S. funds is \$75.00 for members of the Auditing Section and \$125.00 for nonmembers of the Auditing Section payable by credit card (VISA or MasterCard only).
