The nomination should be accompanied by full information concerning the nominee's personality, training and research work. Six copies of each item should be submitted. No Member may send in more than one nomination. A list of the nominee's publications, if any, and six copies of the publication or manuscript for which the award is to be given should also accompany the nomination. At the discretion of the Committee on Scientific Awards, the award may be given for work published during the year prior to December 1 of the year preceding the award. The nominee should be actively engaged at that time in the line of research for which the award is to be made.

**Announcement:** The name of the winner will be announced in *DIABETES*. The winner will be invited to present a paper on his work at the Annual Meeting. Papers considered for the award must be submitted with the idea that they will be published in whole or in part in *DIABETES* if found acceptable to the Editor and/or Editorial Board. If the Committee should decide that no outstanding work has been presented for this consideration, the award will not be made.

**Award:** In addition to the monetary award and medal, traveling expenses will be given to make it possible for the recipient to receive his award in person at the Annual Meeting.

## NEWS OF AFFILIATE ASSOCIATIONS

THE DIABETES ASSOCIATION OF GREATER CHICAGO will conduct its Tenth Annual Symposium on Diabetes at Northwestern University Medical Center, Thorne Hall, 740 Lake Shore Drive, Chicago, on Friday, Nov. 10, 1967, with registration beginning at 8:30 a.m.

The morning session will be devoted to a descriptive review of early diabetes and prediabetes. Topics will include the genetics of diabetes, microvascular disease in diabetes and prediabetes, obesity as a diabetogenic stress and the biochemical characteristics of early diabetes. The afternoon session will focus on clinical problems, including the spectrum of therapy in juvenile diabetes, the dietetic requirements in diabetes and the clinical aspects of early diabetes. Henry T. Ricketts, M.D., will deliver the Tenth Annual Woodyatt Lecture during the morning session. He will be introduced by Arthur R. Colwell, Sr., M.D.

Other speakers will include Drs. T. S. Danowski, University of Pittsburgh School of Medicine; Guy Hollifield, Northwestern University School of Medicine; John W. Farquhar, Stanford University School of Medicine; A. Donald Merritt, Indiana University Medical Center; Lillian Recant, Georgetown University School of Medicine; Lester B. Salans, The Rockefeller University; and Marvin D. Siperstein, The University of Texas Southwestern Medical School.

Robert Metz, M.D., and Ralph E. Dolkart, M.D., both of Northwestern University School of Medicine, are Co-Chairmen of the Scientific Programs Committee.

Registration is free for members of the Diabetes Association of Greater Chicago or the American Diabetes Association and for medical students and resident house staff members and dietitians. ### LEVINE ELECTED IDF PRESIDENT

Rachmiel Levine, M.D., New York, a past President of the American Diabetes Association, was elected President of the International Diabetes Federation on Aug. 2, 1967, at the Sixth Congress of the Federation in Stockholm. Dr. Levine, who succeeded Howard F. Root, M.D., of Boston, will serve for a three-year term.

The International Diabetes Federation is composed of thirty-four organizations and represents most of the diabetes associations of the world. Its purpose is to coordinate their activities and promote the ready exchange of research results, of methodology, and of information regarding clinical and public health aspects of the field. The Federation, whose headquarters are in Utrecht, the Netherlands, has convened an international congress every three years since 1952.
