## Future Meetings and Events

### SEVENTH RESEARCH SYMPOSIUM

The American Diabetes Association will hold its Seventh Research Symposium at the Sheraton-Boston Hotel in Boston, September 20-21. "Growth Hormone: Secretory Control, Endocrine Interrelationships, Metabolic Effects and Bearing upon Clinical Diabetes Mellitus" will be the subject of the sessions. The Symposium is an activity of the Committee on Research, of which Jerome W. Conn, M.D., Ann Arbor, is Chairman. Solomon A. Berson, M.D., and Rosalyn S. Yalow, Ph.D., both of New York, will be Director and Associate Director of the Symposium, respectively. The Program is scheduled to be mailed during the summer, along with registration information. The Symposium is open to Honorary and Active Members of the Association and to others by invitation.

### SIXTEENTH POSTGRADUATE COURSE

"Diabetes in Review: Clinical Conference 1969" is the subject of the Sixteenth Postgraduate Course of the American Diabetes Association to be presented at The Denver Hilton in Denver, Colorado, January 24-26.
