The DIABETES ASSOCIATION OF GREATER CHICAGO will conduct its Twelfth Annual Symposium on Diabetes on Friday, November 21, at the University of Chicago Center for Continuing Education, 1307 East 60th Street, Chicago 60637. The Symposium will be devoted to "Clinical Applications of Newer Knowledge in Diabetes." The morning program will open with a discussion on "Diabetic Retinopathy" from the investigative and clinical point of view. Participants will include David G. Cogan, M.D., Boston; David Schoch, M.D., Chicago; and Arthur R. Colwell, Sr., M.D., Chicago. Faculty members from the various medical institutions in Chicago will then hold a series of workshops for smaller groups of the attending audience dealing with special problems in diabetes, continuing into the luncheon period.

Randall G. Sprague, M.D., Ph.D., Rochester, Minnesota, will deliver the Thirteenth Woodyatt Memorial Lecture in the afternoon, his subject being the impact of investigative knowledge on clinical application to diabetes mellitus. He will be introduced by Dr. Colwell.

Registration, which will begin at 8:30 a.m., is free for members of that Association or the American Diabetes Association and for medical students and resident house staff members and dietitians. Stewart, M.D., Associate Professor in Psychiatry and Pediatrics, Washington University Medical School; "The Sorbitol Pathway and Diabetic Complications," by Kenneth H. Gabbay,

M.D., Deputy Chief, Diabetes and Arthritis Field Research Unit, U.S. Public Health Service, Boston; and "Polyol Accumulation in Diabetic Nerve," by John Ward and Harry Keen, Department of Medicine, Guy's Hospital Medical School, London.
