The NEW YORK DIABETES ASSOCIATION held a spring open meeting at New York University Medical Center Auditorium on Thursday, May 21. Guest speakers were Martin G. Goldner, M.D., Director of Medicine, Jewish Hospital and Medical Center of Brooklyn, and Charles Kilo, M.D., Assistant Professor of Clinical Medicine, Washington University School of Medicine, St. Louis; Dr. Goldner spoke on "Hypoglycemic Treatment and the Vascular Complications of Maturity Onset Diabetes;" and Dr. Kilo on "Capillary Basement Membrane Alterations in Diabetes Mellitus."

NEWS NOTES

NEW U.S. PHARMACOPEIA

U.S.P. XVIII, a completely revised *Pharmacopeia*, was published in April, and will become effective September 1. The *Pharmacopeia* continues to provide standards and tests for demonstrating the strength, quality, and purity of those drugs representing the best in current medical teaching and practice. A total of 1,103 monographs, of which 847 were carried over from the 905 titles official in the preceding edition, are included in U.S.P. XVIII. The fifty-eight previously recognized items now eliminated comprise a smaller number of deletions than usual.

ADA MEMBERS PARTICIPATE IN POSTGRADUATE COURSES

Joseph D. Brown, M.D., William E. Connor, M.D., Ann A. Steele, M.D., and Daniel B. Stone, M.D., all of Iowa City, took part in "Internal Medicine 1970: Old Principles—New Practices" June 8-12 at the University of Iowa in Iowa City. The Course was presented by The American College of Physicians as a tribute to William B. Bean, M.D., who has been appointed to the position of Sir William Osler Professor of Medicine, College of Medicine, University of Iowa.
