Declaration of the Americas

The Declaration of the Americas on Diabetes (DOTA) is evolving into a movement with the purpose to better the health of people affected by or at risk for diabetes in the Americas by the year 2000 and beyond. In 1998, over 30 million people are estimated to have diabetes in the Americas, a quarter of the total diabetic population for the world. Approximately half of these people are in Latin America and the Caribbean, where the caseload is increasing more rapidly than in North America. This is the challenge the DOTA stakeholders are facing in their efforts to implement the 10-point plan outlined in the DOTA document. The 10 points are as follows:

- 1. Determine the epidemiology and economic burden of diabetes
- 2. Establish diabetes strategies
- Develop and implement diabetes programs
- Allocate resources for diabetes prevention and management
- 5. Develop and implement integrated health care model
- 6. Make available and affordable insulin and other medications
- 7. Make available diabetes education
- 8. Promote diabetes public awareness via nongovernmental organizations
- 9. Implement quality-of-care information systems
- 10. Stimulate partnerships among stakeholders

Through the DOTA, the nongovernmental and governmental sectors have come together in many of the countries in the Americas. Nongovernmental organizations are now involved with many national diabetes programs and initiatives that are taking place to encourage more interaction

and establish stronger diabetes networks. For example, such networks are getting stronger, and there is a commitment from not only the Ministry of Health but also the Ministry of Social Development and other governmental agencies to help the Diabetes Association of Trinidad and Tobago with its efforts to better the lives of people with diabetes. Also, the Diabetes Society of Argentina is providing advice in cases of job discrimination and is working toward the establishment of an antidiscriminatory law for people with diabetes in Argentina. This society has also established a partner-

ship with the Commission of the Argentinean Diabetes Federation to establish joint efforts in many areas for the fight against diabetes. The DOTA Bulletin on Diabetes provides a forum where such initiatives can be published and distributed to all the DOTA stakeholders and other interested parties.

The DOTA task groups that so far have been formed are developing reference and position statements in areas such as education, quality-of-care information systems, and the assessment of the availability of insulin and other diabetes supplies. The next steps in the movement are the creation of action plans within these core areas and the establishment of DOTA country groups to facilitate the implementation plan of the DOTA and to strengthen the networks between countries.
