WASHINGTON, D.C., IS SITE OF THIRTY-SECOND ANNUAL MEETING

The Scientific Sessions of the Thirty-second Annual Meeting of the American Diabetes Association will be held at the Washington Hilton in Washington, D.C., June 24-25. Dr. Dorothy C. Hodgkin of Oxford University will deliver the Banting Memorial Lecture at the close of the Scientific Sessions on Saturday morning, June 24, and will receive a Banting Medal. Her lecture is titled "The Structure of Insulin." The Central Council will meet Thursday, June 22, and the Board of Directors, Friday, June 23. Pertinent information about the Meeting, together with a hotel reservation card, was mailed to all Members of the Association in January.

The titles of papers to be presented, those to be read by title, and the Abstracts of both, will be published as a supplement to this Journal prior to the Meeting. It will be distributed without charge to Members of the Association and to subscribers to the Journal.

FOURTH ALLIED HEALTH POSTGRADUATE COURSE IN DIABETES APRIL 17-19

As previously announced, the American Diabetes Association in cooperation with Vanderbilt University will hold the Fourth Allied Health Postgraduate Course in Diabetes April 17-19 in Nashville, Tennessee. Holiday-Inn Vanderbilt will be headquarters hotel, but the course itself will be on campus. The program was developed by Alan L. Graber, M.D., Director of the Course, with Co-Directors Oscar B. Crofford, M.D., Philip W. Felts, M.D., and Addison B. Scoville, Jr., M.D. It will be presented under the auspices of the Committee on Professional Education of the Association, chaired by Karl E. Sussman, M.D. of Denver.

The Course is directed principally to nurses, nutritionists and dietitians. Fee for Members of the Association is \$60.00 and for nonmembers \$75.00. The cost of the buffet luncheons, which are an integral part of the course, will be \$1.75 each, or a total of \$5.25. The latter sum will be added to the regis-

tration fee. The preliminary program, together with the list of faculty was published in the February issue of this Journal. A program announcement was sent to all Members of the Association during the month of March. The program is approved by The American Dietetic Association for thirteen hours of continuing education.

NINETEENTH POSTGRADUATE COURSE

"Diabetes in Review: Clinical Conference 1972," the Nineteenth Postgraduate Course of the American Diabetes Association

was held at the Sheraton-Four Ambassadors in Miami, Florida, January 24, 25 and 26.

The Course was given in cooperation with the University of Miami School of Medicine. The program was developed by Daniel H. Mintz, M.D., Miami, who was Director of the Course, and a planning group of the Committee on Professional Education: George F. Cahill, Jr., M.D., of Boston; Stefan S. Fajans, M.D., of Ann Arbor; and Dr. Sussman.

The GREATER AKRON AREA DIABETES ASSOCIATION will conduct its Fifth Annual Postgraduate Seminar at the Eva P. Craig Auditorium-Akron General Medical Center in Akron on April 12.

Featured speakers at the Seminar and their topics are: George F. Cahill, Jr., M.D., Boston, "Nonketotic Comas"; Donnell D. Etwiler, M.D., Minneapolis, "Diabetes in Children and Adolescents"; Daniel H. Mintz, M.D., Miami, "Diabetes in Pregnancy"; and Thaddeus E. Prout, M.D., Baltimore, "Current Concepts in Therapy in Diabetes Mellitus."

Also on the Seminar program are John C. Johns, M.D., Jack H. Mostow, M.D., Charles W. Reynolds, M.D., and Thomas R. Riley, M.D., all of Akron. They will participate, with the visiting lecturers listed above, as leaders of three workshops on "Daily Problems in the Therapy and Management of the Diabetic Patient."

The DIABETES ASSOCIATION OF THE CINCINNATI AREA and the Department of Continuing Education, College of Medicine, University of Cincinnati, will present the Sixth Postgraduate Symposium in Diabetes on April 12. The Symposium will be held at the Carrousel Inn, 8001 Reading Road, in Cincinnati, from 9:30 a.m. to 5:00 p.m. Registration fee is \$10.00.

The William H. Muhlberg Memorial Lecture will be delivered by George F. Cahill, Jr., M.D., Professor of Medicine, Harvard University Medical School and Director, Elliott P. Joslin Research Laboratory. He will speak on "Lipid Metabolism, Obesity, and Diabetes."

Other speakers and their subjects are: Peter H. Forsham, M.D., Professor of Medicine and Pediatrics, University of California Medical Center, San Francisco ("Beta Cell Failure and the Diabetes Syndrome"); Albert I. Winegrad, M.D., Professor of Medicine, School of Medicine, and Director, The George S. Cox Medical Research Institute, University of Pennsylvania, Philadelphia ("The Biochemical Basis of Vascular Disease and Neuropathy").

The afternoon session will consist of a panel discussion moderated by Dr. Cahill on the topic, "The Current Status of the Oral Antihyperglycemic Drugs." Panelists and their topics are: Dr. Cahill ("Metabolism and Pharmacology of the Oral Antihyperglycemic Drugs"); Kenneth Kreines, M.D., Associate Professor of Medicine and Chief Clinician in Diabetes, University of Cincinnati Medical Center ("Clinical Trials with the Oral Drugs"); Dr. Forsham, Dr. Winegrad and Harvey C. Knowles, Jr., M.D., Professor of Medicine and Director of the Metabolism Division and Clinical Research Center, University of Cincinnati Medical Center ("Criticisms of the Clinical Trials"). All panelists will respond to the last topic, "What Do We Do Now?"
