

place in the text. Written permission from authors of unpublished data should be obtained and submitted.

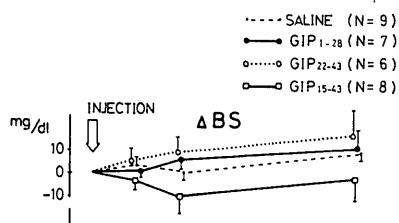
Authors are responsible for the accuracy of the references.

Tables

Tables should be typed double-space on separate sheets, with number (Arabic) and title. Symbols for units should be confined to column headings. Abbreviations should be kept to a minimum, and those used should be explained.

Illustrations

Figures should be professionally drawn and photographed and submitted as black-and-white glossy prints. They should be untrimmed, unmounted, unstapled. Name(s) of author(s), figure number, and the top of figure should be noted on a label affixed to the back of each illustration. It will ease typesetting if unusual symbols are included as art work within the figure, as below.



If photographs of patients are used, either the subjects should not be identifiable, or written permission to use the illustration for publication must be included.

Legends for illustrations should be typed (double-space) consecutively on a separate sheet.

Color photographs are published at the author's expense.

Review and Action

All contributions (including solicited articles) are critically reviewed by the editors, members of the editorial board, and/or appropriate consultant reviewers. Reviewers' comments are usually returned to authors. The decision of the Editor is final.
