DIABETES EDUCATION UPDATE AND PRACTICUM

"Diabetes Education Update" is an intensive, week-long workshop for nurses, dietitians, and diabetes educators involved in teaching, treating, and counseling people with diabetes and their families. The workshop will be held April 21-25 and September 8-12, 1986 at the Hilton Inn East in Wichita, Kansas.
