Conner Bailey is Professor Emeritus of Rural Sociology at Auburn University. Prior to joining the Auburn faculty in 1985, Bailey worked at the International Center for Living Aquatics Resource Management (ICLARM, now the WorldFish Center) and in the Marine Policy Center at Woods Hole Oceanographic Institution. He began research on marine fisheries in the mid-1970s while working on his doctoral dissertation and on aquaculture in the early 1980s while working in Southeast Asia with ICLARM. He has taught tropical fisheries management at the Norwegian College of Fisheries, University of Tromsø (1998–2002) and has worked with various international agencies (FAO, World Bank, USAID) on issues related to fisheries management and aquacultural development.

Robert M. Chiles is an Assistant Professor in the Department of Agricultural Economics, Sociology, and Education and the Department of Food Science and a Research Associate in the Rock Ethics Institute at Penn State University. His scholarship examines the ethical and empirical dimensions of food system controversies, the interconnections between food culture and political economy, and the methods and social processes by which agricultural science is performed. Chiles's research has been published in *Sociologia Ruralis*, *Agriculture and Human Values*, *Journal of Agricultural and Environmental Ethics*, *Journal of Consumer Behaviour*, *Journal of Food Science Education*, and *Contexts* and in *Controversies in Science and Technology, Vol. 4: From Sustainability to Surveillance* (2014).

Celize Christy completed her MS in Rural Sociology and International Agricultural Development at Penn State University. With a background in animal science, her research interests lie at the intersection of livestock production, smallholder livelihoods, and Sub-Saharan African agricultural development. She has had experience in research projects and rural extension efforts with poultry farmers in the Kamuli District of Uganda. Her thesis examined the use of local knowledge and community networks on preventive poultry health measures in Rwanda.

Riva C. H. Denny is a Research Associate in the Department of Sociology at Michigan State University. Her research focuses on agriculture and the environment, as

well as food systems and food security. She has a PhD in sociology from Michigan State University, and an MS in rural sociology from Auburn University. Her work has been published in *Rural Sociology* (2017 Best Paper Award winner), *Sociology of Development, Society and Natural Resources*, and *Environment Systems and Decisions*.

Carrie Freshour is an Assistant Professor in the Division of Social Sciences and History at Delta State University. Her research interests include the political economy of food work, social reproduction, and racialization in the U.S. South. She has conducted ethnographic fieldwork in Northeast Georgia, which included more than five months of working “on the line” in a large processing plant and conducting fifty oral histories with current and former poultry plant workers in order to understand the daily struggles and experiences of this racialized and gendered workforce.

Philip H. Howard is an Associate Professor in the Department of Community Sustainability at Michigan State University. He is the author of *Concentration and Power in the Food System: Who Controls What We Eat?* (2016), which won the Fred Buttel Outstanding Scholarly Achievement Award from the Rural Sociological Society in 2016. He is a former president of the Agriculture, Food and Human Values Society, and is currently a member of the International Panel of Experts on Sustainable Food Systems, and a member of the editorial board of *Agriculture and Human Values*. His visualizations of food industry changes have been featured in numerous media outlets.

Elizabeth Ransom is an Associate Professor in the School of International Affairs and a Senior Research Associate in the Rock Ethics Institute at Penn State University. She coedited *Rural America in a Globalizing World: Problems and Prospects for the 2010s* (2014). Her areas of expertise include international development and globalization, the sociology of agriculture and food, social studies of science and technology related to agriculture and food, and gender and development. For the past two decades one of her primary research interests has focused on livestock production in eastern and southern Africa. She has published articles in journals such as *Gender & Society*, *Journal of Rural Studies*, and *Rural Sociology*.

Thomas K. Rudel got his first exposure to tropical rain forests right after college when he worked as a Peace Corps volunteer in the Ecuadorian Amazon. It proved to be a pivotal experience! After earning a PhD in sociology, he carried out a series of studies of the social forces that have caused the recent destruction of so many tropical forests. He has written two books and more than twenty-five articles on cattle ranching and the loss of tropical forests. These studies have included both detailed, village-level studies in the Ecuadorian Amazon and quantitative analyses at the global scale. He is currently a Distinguished Professor of Human Ecology and Sociology at Rutgers University.

Mindi Schneider is an Assistant Professor of Sociology of Development and Change at Wageningen University in the Netherlands. She specializes in political economy

of development, environmental sociology and political ecology, and international agriculture and rural development. Her current research centers on the social, political, and ecological transformations that accompany the industrialization of China's agro-food system, and on global food and agricultural politics more broadly. She has published in journals including *Geoforum*, the *Journal of Agrarian Change*, the *Journal of Peasant Studies*, and *Agriculture and Human Values*.

Nhuong Tran is a scientist at WorldFish based in Penang, Malaysia. He joined WorldFish in 2011 and since then has been working on various areas on fish supply and demand modeling, climate change impact and adaptation in aquaculture, and analysis of aquaculture system and value chain performance. Tran has published his research in journals such as the *American Journal of Agricultural Economics*, *World Development*, *Marine Policy*, *Marine Resource Economics*, *Agribusiness*, *Global Food Security*, and *Journal of Cleaner Production*.

Bill Winders is an Associate Professor in the School of History and Sociology at the Georgia Institute of Technology. He specializes in the areas of political sociology, social movements, the world economy, inequality, and the political economy of food and agriculture. His current research examines two issues: (1) the global meat industry, focusing on the production, consumption, and trade of meat in the world economy, and (2) food crises in the world economy, such as the 2008 food crisis that saw food prices and world hunger rise dramatically. He is the author of two books: *The Politics of Food Supply: U.S. Agricultural Policy in the World Economy* (2009), and *Grains* (2017).
