GUSTAVO J. ARCIA is Senior Economist in the Center for International Development, Research Triangle Institute, and Adjunct Associate Professor of Public Policy at Duke University. Most of his current work is in social sector policy, education reform, poverty measurement, and poverty reduction policies. During the past five years he has worked in education reform in Ecuador, Honduras, and Nicaragua, and poverty analysis in Nicaragua and Uzbekistan. He has also analyzed population-environment interactions in Costa Rica and Ecuador, and conducted extensive studies of farming systems in West Africa and Latin America. He is the author of several monographs and book chapters on education reform in Latin America, and on poverty, economic, and social policy in Central America.

WILLIAM ASCHER is Professor of Government and Economics, Dean of the Faculty, and Vice-President at Claremont-McKenna College. Previously he was Director of Duke University's Center for International Development Research. His research is on policy-making processes in developing countries, natural resource policymaking, Latin American and Asian political economy, and forecasting methodologies. His books on resources and development include *Scheming for the Poor: The Politics of Redistribution in Latin America* (Harvard University Press, 1984), *Natural Resource Policymaking in Developing Countries* (with Robert G. Healy, Duke University Press, 1990), *Communities and Sustainable Forestry in Developing Countries* (ICS Press, 1994), *Why Governments Waste Natural Resources* (Johns Hopkins University Press, 1999), and *The Caspian Sea: A Quest for Environmental Security* (ed. with Natalia Mirovitskaya, Kluwer, 2000).

FIKRET BERKES is Professor of Natural Resources at the University of Manitoba, Winnipeg, Canada. His main area of expertise is common-property resources and community-based resource management, currently focusing on traditional ecological knowledge and co-management. He teaches in these areas, contributes to theory development, and carries out applied work both internationally and in the Canadian North. He contributes as well to the literature of human ecology and conservation, biodiversity, ecological economics, and environmental assessment. He has over one hundred

scholarly publications, including the books *Sacred Ecology* (Taylor and Francis, 1999), *Linking Social and Ecological Systems* (Cambridge University Press, 1998, coedited with Carl Folke), and *Common Property Resources* (Belhaven, 1989).

GARRY D. BREWER is the Frederick K. Weyerhaeuser Professor at Yale University's Schools of Management and Forestry and Environmental Studies (1985–1991; 2001–). Before returning to Yale, he was Professor and Dean of the University of Michigan School of Natural Resources and Environment (1991–1998) and Professor of Environmental Policy and Management and Dean of University Extension at the University of California, Berkeley (1998–2001). In 1998 he was the King Carl XVI Gustaf Professor of Environmental Sciences and Management in Sweden, and was elected to the Swedish Royal Academy. He was also a Presidential appointee to the U.S. Nuclear Waste Technical Review Board (1992–1997). The author of nine books on policy analysis, simulation and modeling, and development, his most recent publications on natural resources and environment include “Science to Serve the Common Good,” *Environment* 39(6) (July 1997); “Closing the Gap between Ecosystem Management and Ecosystem Research,” *Policy Sciences* 31(1) (February 1998); and “The Challenges of Interdisciplinarity,” *Policy Sciences* 32(4) (December 1999).

DANIEL W. BROMLEY is Anderson-Bascom Professor of Applied Economics at the University of Wisconsin-Madison, and has been editor of the journal *Land Economics* since 1974. He has published extensively on natural resource and environmental economics and on economic development. He has been a consultant to the Global Environment Facility, the World Bank, the Ford Foundation, the U.S. Agency for International Development, the Asian Development Bank, the Organization for Economic Cooperation and Development, and the New Zealand Ministry for the Environment. He has published nine books, most recently *Environment and Economy: Property Rights and Public Policy* (Blackwell, 1991); *The Social Response to Environmental Risk* (Kluwer, 1992); *Making the Commons Work: Theory, Practice, and Policy* (ICS Press, 1992); *The Handbook of Environmental Economics* (Blackwell, 1995); and *Sustaining Development: Environmental Resources in Developing Countries* (Elgar, 1999). He is now writing “Sufficient Reason: Institutions and Economic Change.”

RONALD D. BRUNNER is Professor of Political Science at the University of Colorado at Boulder. A native of Colorado, he was educated at Yale University where he received his B.A. and Ph.D. degrees. He was a tenured member of the faculty at the University of Michigan, and has held research positions at Harvard University and in the U.S. Congress. He is interested primarily in the integration of theory and practice in the policy sciences including problems of epistemology in policy inquiry, the symbolic instruments of politics and policy, and context-sensitive methods. His publications cover a wide variety of practical problems, including energy, welfare, space policy, global climate change policy, and natural resources policy, including “Harvesting Experience: A Reappraisal of the U.S. Climate Change Program,” *Policy Sciences* 32(2) (June 1999) and “A Practice-Based Approach to Ecosystem Management,” *Conservation Biology* 11(1) (February 1997). On the subject of energy policy, he wrote *Community Energy Options: Getting Started in Ann Arbor* (University of Michigan Press, 1982).

ELSA CHANG is an Associate in the World Resources Institute's (WRI) Institutions and Governance Program. Over the past five years, Ms. Chang, a native of Guatemala,

has led and managed WRI's collaboration on strengthening national and regional institutions' framework for environmental management and policy planning in Central America. Currently, she manages WRI's strategic policy research program aimed to catalyze actions to implement the Mesoamerican Biological Corridor in the Central American region. Before joining WRI, Ms. Chang conducted a research project on Forest Policies and Administration in Peru and Bolivia, was Executive Assistant and Technical Adviser for the Central American Commission on Environment and Development (CCAD) and Guatemala's National Commission on the Environment (CONAMA). Formerly a Mesoamerican archaeologist, she worked for various archaeological projects throughout Guatemala. Ms. Chang holds an M.A. in International Development Policy from the Sanford Institute of Public Policy at Duke University.

TIM W. CLARK is Professor (adjunct) in the School of Forestry and Environmental Studies and Fellow in the Institution for Social and Policy Studies, Yale University, and board president of the Northern Rockies Conservation Cooperative in Jackson, Wyoming. He received his Ph.D. from the University of Wisconsin-Madison in 1973. His interests include conservation biology, organization theory and management, natural resources policy, and the policy sciences. He has written over 300 papers, including a recent one addressing interdisciplinary problem solving in the Greater Yellowstone Ecosystem. His books include *Mammals in Wyoming* (coauthor, 1987), *Conservation Biology of the Black-Footed Ferret* (1989), *Tales of the Grizzly* (coauthor, 1993), *Greater Yellowstone's Future: Prospects for Ecosystem Science, Management, and Policy* (1994), *Endangered Species Recovery: Finding the Lessons, Improving the Process* (1994), *Averting Extinction: Reconstructing Endangered Species Recovery* (1997), and *Carnivores in Ecosystems: The Yellowstone Experience* (coedited). He has served as a member of the Policy Review Committee on Research and Resource Management in the U.S. National Park Service. He is also a member of three species survival commissions of the IUCN-World Conservation Union.

HELEN CORBETT is a writer and researcher who spent eighteen years working on the seal islands of the Bering Sea. Her research of the northern Aleut culture, resource economies, and Bering Sea island systems has taken her to the Pribilof Islands and Alaska (1981–1993) and the Commander Islands and Kamchatka (1994–present). She has published numerous articles and research papers about her Bering Sea work and coproduced four films with Susanne Swibold on the Pribilof Islands. She is a founder and codirector of the Amiq Institute and a research associate at the Arctic Institute of North America, University of Calgary. She holds a B.A. (University of Alberta) and Bachelor of Journalism (Carleton University).

GERALD A. EMISON is Senior Adviser to the Chief Financial Officer of the U.S. Environmental Protection Agency (EPA). Prior to this he managed EPA's Pacific Northwest regional office and directed EPA's air-quality planning program during the development of the Clean Air Act of 1970. He holds an undergraduate degree in civil engineering and graduate degrees in city planning, political science, and engineering management. He received a doctorate in City and Regional Planning from the University of North Carolina, Chapel Hill, and is a diplomate of the American Academy of Environmental Engineers and a member of the American Institute of Certified Planners.

ROBERT G. HEALY (Ph.D., Economics, University of California, Los Angeles) is Professor of Environmental Policy in the Nicholas School of the Environment, Duke University. Before coming to Duke in 1986, he was on the research staff of the Conservation Foundation/World Wildlife Fund, Resources for the Future, and the Urban Institute, all in Washington, D.C. He has written several books on land-use policy, U.S. public lands, and agricultural and forest-land use, including *Competition for Land in the American South: Agriculture, Human Settlement, and the Environment* (Conservation Foundation, 1985) and (with William Ascher) *Natural Resource Policymaking in Developing Countries* (Duke University Press, 1990). At Duke, he has been director of the Center for International Studies and the Center for North American Studies. His current research concerns the relation of protected area management to local economic development, with particular emphasis on tourism and sustainable craft production.

RANDALL A. KRAMER is Professor of Resource and Environmental Economics in the Nicholas School of the Environment and the Department of Economics at Duke University. Before coming to Duke in 1988, he taught at Virginia Polytechnic Institute and State University, and was a visiting fellow at the Economic Growth Center, Yale University, and visiting economist, Directorate General of Forest Protection and Nature Conservation, Indonesian Ministry of Forestry. He has consulted with the World Bank, U.S. Agency for International Development, the U.S. Department of the Interior, the Organization of American States, and the Asian Development Bank. He received his B.A. in Economics from the University of North Carolina, his Masters of Economics from North Carolina State University, and Ph.D. in Agricultural Economics at the University of California, Davis. His research has focused on ecosystem valuation, tropical forest management, environmental impacts of agriculture, economics of biodiversity, and natural resource management in developing countries. He is currently studying the relationship between human population change and the use of coastal resources in Indonesia. He is the author of over sixty papers and is coeditor of a recent book, *Last Stand: Protected Areas and the Defense of Tropical Biodiversity* (Oxford University Press).

NATALIA S. MIROVITSKAYA has been on the faculty at Duke University since 1995. She has specialized on the interplay among world economic trends, international relations, and natural resources management. She also leads a Duke faculty seminar on the Black and Caspian Seas and codirected an Advanced Research Workshop on the Caspian Sea in 1999. Prior to joining Duke, she was a Senior Fellow at the Institute of World Economy and International Relations, Russian Academy of Sciences. She has published extensively on international environmental cooperation, gender issues and resource management, and FSU environmental issues. She published *International Aspects of the World Food Problem* (International Relations, 1983) and *Biological Resources of the World Oceans: International Aspects* (Nauka, 1991). With William Ascher she has coedited *The Caspian Sea: A Quest for Environmental Security* (Kluwer, 2000).

NORMAN MYERS is an independent scientist with an interdisciplinary background based on systems ecology and resource economics. He makes frequent forays into the arena of public policy, as in his recent book *Perverse Subsidies: Tax Dollars Undercutting Our Economies and Environments Alike*. He has lectured at over one hundred American universities and undertakes projects with organizations such as the U.S.

National Academy of Sciences, the World Bank, OECD, and the European Commission. His current interests lie with over- and misconsumption in affluent nations, and with the 800 million new consumers in developing and transition nations. His other recent books include *Gaia: An Atlas of Planet Management*, *Ultimate Security: The Environmental Basis of Political Stability*, and *Scarcity or Abundance?: A Debate on the Environment* (with Julian Simon).

RENAT A. PERELET has been Research Leader, Laboratory of Systems Ecology, Institute for Systems Analysis, Russian Academy of Sciences, since 1987. In 1996–1998 he was also Senior Expert at the Harvard Institute of the International Development, Moscow Office. He is the author of over sixty papers and books on environmental management. He has served as vice-president of the Russian Branch of the International Society for Ecological Economics and as Full Member (Academician) of the International Academy of Informatics. Dr. Perelet has consulted with the Parliament of the Russian Federation on the issues of sustainable development strategy for Russia, bills on Lake Baikal, environmental security for Russia, and a follow-up to UNCED. He is actively involved in the activities of Russian nongovernmental organizations, serving as a board member of the Russian Association for United Nations, the Ecological Union, and the Russian environmental weekly *Zeleny mir*. He is a member of the Advisory Committee of the Association for University Environmental Education in Central and Eastern Europe (Hungary).

STEVE RAYNER is Professor of Environment and Public Affairs and Professor of Sociology at Columbia University. He is also Chief Social Scientist at the International Institute for Climate Prediction. Previously he was a Chief Scientist and leader of the Global Change Group at the Pacific Northwest National Laboratory, where he was the coeditor (with Elizabeth Malone) of the four-volume series *Human Choice and Climate Change*. He has received several awards for his work on risk management and environmental policy analysis. He has served on various national and international bodies concerned with the human dimensions of global change, including the Intergovernmental Panel on Climate Change. He has testified before Congress on climate change research policy and prepared reports to Congress on climate policy and implementation.

DENNIS A. RONDINELLI is Glaxo Distinguished International Professor of Management, and Director of the Center for Global Business Research, Kenan Institute of Private Enterprise, University of North Carolina at Chapel Hill. His research (in Asia, Central Europe, Latin America, and Africa) is on corporate environmental management, global business strategy, economic reform policy, privatization, urban and regional economic development, business opportunities in emerging market economies, employment-generation policies in developing countries, international trade and investment, and program and project management for economic development. He has published sixteen books and more than two hundred monographs, book chapters, and articles in scholarly and professional journals. He has served as an advisor, consultant, or expert to the U.S. State Department's Agency for International Development, the World Bank, the Asian Development Bank, the Canadian International Development Agency, the International Labor Office, the United Nations Development Programme, and to private corporations.

DANIEL SAREWITZ is Managing Director, and Senior Research Scholar, of Columbia University's Center for Science, Policy, and Outcomes. His work focuses on understanding the connections between scientific research and social benefit, and on developing policies to strengthen such connections. He is the author of *Frontiers of Illusion: Science, Technology, and the Politics of Progress* and coeditor of *Prediction: Science, Decision Making, and the Future of Nature*. Previously he was Director of the Geological Society of America's Institute for Environmental Education. From 1989 to 1993, he worked on Capitol Hill, first as a Congressional Science Fellow, then as science consultant to the House of Representatives Committee on Science, Space, and Technology, where he was involved in issues ranging from science education to federal research policy. As a researcher in geology, his publications focused on processes of mountain building and basin formation along active plate boundaries, with field studies in Argentina, the Philippines, and Tajikistan.

SUDHIR SHETTY is Principal Economist in the Office of the Chief Economist, Africa Region, of the World Bank. He joined the World Bank in 1987, and his previous assignments have been in the Eastern and Southern Africa Departments, as well as in the East Asia and Pacific Region. He has prepared economic reports on environmental problems and policies in Thailand and the Philippines, and was a member of the core team that prepared the 1992 *World Development Report* entitled "Development and the Environment." Before joining the World Bank, he taught public policy and economics at Duke University. He has a Ph.D. in economics from Cornell University.

MARVIN S. SOROOS is Professor of Political Science and Public Administration at North Carolina State University. He has published widely in the fields of international public policy and global environmental politics and policy, including *The Global Predicament: Ecological Perspectives on World Order*, *The Environment in the Global Arena*, *Beyond Sovereignty: The Challenge of Global Politics*, and *The Endangered Atmosphere: Preserving a Global Commons*. His articles have appeared in the *Journal of Peace Research*, *International Studies Quarterly*, *International Organization*, *Environmental Review*, *Policy Studies Journal*, *International Political Science Journal*, *Environment*, and *Human Ecology*. He has been president of the Southern Regional Section of the International Studies Association and chair of the association's Environmental Studies Section. He has chaired the Environmental Studies Section of the International Studies Association and been active in the International Human Dimensions of Global Change Program.

DAVID SPENCE is Professor of Management Science and Information Systems at the University of Texas at Austin. He served as a policy analyst at the North Carolina Alternative Energy Corporation and the North Carolina Department of Administration, and as an attorney in private practice. His research has focused on environmental law, energy, and business law, with a particular emphasis on regulation and procedural reform. He received his law degree from the University of North Carolina at Chapel Hill and his doctorate from Duke University.

TODDI A. STEELMAN is Assistant Professor at North Carolina State University's Department of Forestry. Her research focuses on the role of public and community involvement in environmental governance. Recent research projects and publications include work on forests, watersheds, open space protection and climate change. Recent

publications include “Innovation in Local Land Protection and Governance: The Case of Great Outdoors Colorado,” “The Public Comment Process: What Does the Public Contribute to National Forest Management?,” “Common Property, Collective Action and Community Opposition,” and “Public Involvement Methods in Natural Resources Policy Making: Advantages, Disadvantages and Tradeoffs.”

SUSAN E. SUBAK is Senior Researcher with the Natural Resources Defense Council’s climate program. Her primary interests are strategies for limiting greenhouse gas emissions from land use and agriculture, and regional climate impact analysis. She is the author of more than fifty professional and technical articles. She has worked as a researcher and lecturer at the School of Environmental Sciences at the University of East Anglia in England, where she is a senior fellow, and is a research associate with the Stockholm Environment Institute and Harvard University. She has served as a principal investigator on major projects sponsored by the European Commission and the United Kingdom’s Department of Environment, and has worked as a consultant for a number of national and international organizations. She is a graduate of Reed College and MIT, and holds a doctorate from the University of East Anglia.

SUSANNE SWIBOLD is a visual artist, photographer, filmmaker, and ecologist who is known internationally for her visual research techniques and her conservation efforts in the Bering Sea. Her research concerns northern native people (Aleuts), resource economies, and island systems; her fieldwork has focused on the Pribilof Islands and Alaska (1981–1993), and the Commander Islands and Kamchatka (1994–present). She is founder and codirector of the Amiq Institute and a research associate at the Arctic Institute of North America, University of Calgary. Her four films on Aleut culture and the environment of the Pribilof Islands received several awards and have been televised in many countries. Her photography is published widely in books and periodicals.

IAN WELSH lectures in Sociology in the School of Social Sciences, Cardiff University. He has a long-standing interest in environmental sociology, spanning nuclear, climate change, and road building issues. His books include *Environment and Society in Eastern Europe* (edited with Andrew Tickle) and *Mobilising Modernity: The Nuclear Moment*. He recently published “Risk, ‘Race’ and Global Environmental Regulation,” in Avtar Brah et al., eds., *Global Futures; Migration, Environment and Globalization*. His research interests also include the social aspects of xenotransplantation—the use of animal tissue and organs in humans.
