

**Alberto Burgio** is professor of history of philosophy at the University of Bologna. His publications on Gramsci include *Gramsci storico* (2003), *Per Gramsci: Crisi e potenza del moderno* (2007), *Gramsci: Il sistema in movimento* (2014), and “On the Transition to Communism,” in *A Companion to Antonio Gramsci: Essays on History and Theories of History, Politics and Historiography*, edited by Davide Cadeddu (2020).

**Cesare Casarino** is professor of cultural studies and comparative literature at the University of Minnesota. He is the author of *Modernity at Sea: Melville, Marx, Conrad in Crisis* (2002), coauthor of *In Praise of the Common: A Conversation on Philosophy and Politics* (2008) with Antonio Negri, coeditor of *Marxism beyond Marxism* (1996) with Saree Makdisi and Rebecca Karl, and cotranslator with Vincenzo Binetti of Giorgio Agamben’s *Means without End* (2000). His essays on literature, cinema, and philosophy have appeared in *boundary 2*, *October*, *Raritan*, *Strategies*, *Paragraph*, *Social Text*, and *Arizona Quarterly*.

**Maria Elisa Cevasco** is professor of cultural studies and literature in English at the Universidade de São Paulo. She has published several articles and books in Brazil and abroad, including *Para ler Raymond Williams* (2001) and the coedited *O espírito de Porto Alegre* (2003).

**Kate Crehan** is professor emerita, College of Staten Island and the Graduate Center, City University of New York. Her publications include *The Fractured Community: Landscapes of Power and Gender in Rural Zambia* (1997), *Gramsci, Culture and Anthropology* (2002), *Community Art: An Anthropological Perspective* (2011), and *Gramsci’s Common Sense: Inequality and Its Narratives* (Duke University Press, 2016).

**Roberto Dainoffo** is professor of Italian and literature at Duke University, where he teaches courses on modern and contemporary Italian culture. His publications include *Place in Literature: Regions, Cultures, Communities* (2000), *Europe (in Theory)* (Duke University Press, 2007, winner of the 2010 Shannon Prize in Contemporary European Studies), and *Mafia: A Cultural History* (2015). He has also edited *Racconti Americani del '900* (1999) and a monographic issue of *Italian Culture* on Giambattista Vico (2017).

**Michael Denning** is William R. Kenan Jr. Professor of American Studies and English at Yale University. He is the author of *Mechanic Accents: Dime Novels and Working-Class Culture in America* (1987), *Cover Stories: Narrative and Ideology in the British Spy Thriller* (1987), and *The Cultural Front: The Laboring of American Culture in the Twentieth Century* (1997).

**Harry Harootunian** is an American historian of early modern and modern Japan with an interest in historical theory. He is professor emeritus of East Asian studies, New York University, and Max Palevsky Professor of History and Civilizations, Emeritus, University of Chicago. His publications include *Marx after Marx: History and Time in the Expansion of Capitalism* (2015), *History's Disquiet: Modernity, Cultural Practice and the Question of the Everyday Life* (2000), *Overcome by Modernity: History, Culture and Commodity in Interwar Japan* (2010), and *Uneven Moments: Reflections on Japan's Modern History* (2019).

**Fredric Jameson** is Distinguished Professor of Comparative Literature at Duke University. The author of numerous books, he has, over the last three decades, developed a richly nuanced vision of Western culture's relation to political economy. He was a recipient of the 2008 Holberg International Memorial Prize. Among his publications are *Postmodernism: Or, The Cultural Logic of Late Capitalism*; *The Cultural Turn; A Singular Modernity*; *The Modernist Papers*; *Archaeologies of the Future*; *Brecht and Method*; *Ideologies of Theory*; *Valences of the Dialectic*; *The Hegel Variations*; and *Representing Capital*.

**R. A. Judy** is professor of critical and cultural studies in the Department of English at the University of Pittsburgh and a member of the editorial collective of *boundary 2, an international journal of literature and culture*. Professor Judy is the author of *(Dis)forming the American Canon: The Vernacular of African Arabic American Slave Narrative* (1992) and has edited numerous special issues and dossiers for *boundary 2*, including *Tunisia Dossier* (2012), *Ralph Ellison: The Next Fifty Years* (2003), *Sociology Hesitant: W. E. B. Du Bois's Dynamic Thinking* (2001), *Reasoning and the Logic of Things Global* (1999), and *Scattered Speculations on Value: Exchange between Etienne Balibar, Antonio Negri, and Gayatri Spivak* (1999).

**Patrizia Manduchi** is professor of history of Islamic countries at the University of Cagliari. She is the president of GramsciLab, the Interdepartmental Centre for International Gramscian Studies. Her publications, which include several contributions on both Gramsci and Islamic politics, include *Università e movimenti studenteschi nell'Egitto*

*contemporaneo (1908–1981)* (2015), *Questo mondo non è un luogo per ricompense: Vita e opere di Sayyid Qutb, martire dei Fratelli Musulmani* (2009), and the coedited volumes *Gramsci in Asia e in Africa* (2010), *Gramsci nel mondo arabo* (2017), and *A lezione da Gramsci: Democrazia, partecipazione politica, società civile in Tunisia* (2019).

**Andrea Scapolo** is assistant professor of Italian at Kennesaw State University. His work on Gramsci in the cultural production of the Italian youth movements has been published in *Annali d'italianistica* and *Italica*.

**Peter D. Thomas** is a historian of political thought, philosophy, and a political theory at Brunel University. He has previously studied and worked at the Universities of Queensland, Naples, Berlin, and Amsterdam. He has published widely on Marxist political theory and philosophy, the history of political thought, and the history of philosophy, and is an editor of the journal *Historical Materialism: Research in Critical Marxist Theory* and author of *The Gramscian Moment*, winner of the Premio internazionale Giuseppe Sormani 2011, awarded by the Fondazione Istituto Piemontese Antonio Gramsci in Turin for the best book or article on Gramsci in the period 2007 to 2011 internationally.

**Catherine E. Walsh** is a senior professor and director of the Latin American Cultural Studies Doctoral Program at the Universidad Andina Simon Bolivar in Quito, Ecuador, where she also coordinates the Afro-Andean Collective Memory Archive. She has been an invited professor and lecturer all around the world. Her recent publications include *On Decoloniality: Concepts, Analytics, Praxis*, cowritten with Walter D. Mignolo (Duke University Press, 2018), *Entretejiendo lo pedagógico y lo decolonial: Luchas, caminos y siembras de reflexión-acción para resistir, (re)existir y (re)vivir* (2018), “Lewis Gordon: Existential Incantations that Cross Borders and Move Us Forward,” in *Black Existentialism: Essays on the Transformative Thought of Lewis R. Gordon* (2019), and “Decolonial Notes to Paulo Freire Walking and Asking,” in *Educational Alternatives in Latin America: New Modes of Counter Hegemonic Learning* (2019).

**Pu Wang** is assistant professor of Chinese and the Helaine and Alvin Allen Chair in Literature at Brandeis University. Having produced a book, two conference seminars, and a number of articles, the major component of his research of the past few years focuses on translation, revolution, and historical imagination in modern Chinese culture. His book *The Translatability of Revolution: Guo Moruo and Twentieth-Century Chinese Culture* (2018) is the first comprehensive study in English of the lifework of Guo Moruo (1892–1978), a towering—and highly controversial—figure of China’s revolutionary century who worked as a Romantic writer, Marxist historian, and prolific translator.

**Cosimo Zene** is professor emeritus of religions and world philosophies at the School of Oriental and African Studies in London. Since his historical-anthropological

research among a group of Dalits in Bengal and Bangladesh, Zene has published extensively on Dalit religions and on the ways Gramsci's thought can establish meaningful associations with the thought of the Dalit leader B. R. Ambedkar in highlighting the Dalits' human, social, and religious experiences. On Gramsci and Dalit thought, he has published several essays in the *International Gramsci Journal*, *felsefelogos*, *Rethinking Marxism: A Journal of Economics, Culture and Society*, and *LARES—Quadrimestrale di Studi Demotnoantropologici*, and edited the volume *The Political Philosophies of Antonio Gramsci and B. R. Ambedkar* (2013).
