SASHA ABRAMSKY is a freelance journalist whose work has appeared in *The Nation*, *The Atlantic Monthly*, *The Village Voice*, and *Rolling Stone*. In 2000 he was awarded a Soros Society, Crime, and Communities Media Fellowship, and in 2010 he was a senior fellow at Demos, a public-policy research organization in New York. His books include *Inside Obama's Brain* (2009) and *Breadline USA: The Hidden Scandal of American Hunger and How to Fix It* (2009).

JESSE DREW is director of technocultural studies at the University of California, Davis, where he specializes in digital arts, media archaeology, documentary studies, and the history of labor. He was for many years a labor activist in factories and manufacturing plants before becoming involved in grassroots video production and the nascent digital-arts movement. He holds a doctorate from the University of Texas in Radio, Television, and Film. He is currently making a feature-length documentary on the politics of country music.

DANIEL HO SANG is assistant professor of ethnic studies and political science at the University of Oregon. His research interests include US racial politics, cultural studies, political identity, social movements, and direct democracy. His book *Racial Propositions: Ballot Initiatives and the Making of Postwar California* (2010) examines California's history of racialized ballot measures in the post-World War II era to unearth the tangled roots of "color-blind" racial politics.

JOSH KUN is associate professor in the Annenberg School for Communication and Journalism and the Department of American Studies and Ethnicity at the University of Southern California, where he is director of the Popular Music Project at the Norman Lear Center. He is author of *Audio-topia: Music, Race, and America* (2005) and coauthor of *And You Shall Know Us by the Trail of Our Vinyl* (2008). As a critic and journalist Kun regularly contributes to *The New York Times* and *Los Angeles Magazine*.

JOE MATHEWS is a journalist and Irvine senior fellow at the New America Foundation. He is author of *The People's Machine: Arnold Schwarzenegger and the Rise of Blockbuster Democracy* (2006) and coauthor with Mark Paul of *California Crackup: How Reform Broke the Golden State and How We Can Fix It* (2010). Mathews is lead blogger for NBC's Prop Zero and a columnist for *The Daily Beast*. He was previously a reporter for *The Los Angeles Times*.

MARK PAUL, a visiting scholar at the Institute of Governmental Studies at the University of California, Berkeley, was formerly deputy treasurer of California and deputy editorial-page editor of the *Sacramento Bee*. He is the coauthor with Joe Mathews of *California Crackup: How Reform Broke the Golden State and How It Can Be Fixed* (2010).

CAROLYN DE LA PEÑA is professor of American studies and director of the Davis Humanities Institute at the University of California, Davis. Her most recent book, *Empty Pleasures: The Story of Artificial Sweetener from Saccharin to Splenda* (2010), examines the rapid proliferation of sugar substitutes in twentieth-century America with particular attention to the food-pharmaceutical collaborations, gendered invention and marketing, and consumer imperatives that drove it.
