

INTERNATIONAL CONGRESS OF CHEMOTHERAPY

The 13th International Congress of Chemotherapy, organized by the Austrian Society of Chemotherapy as a member of the International Society of Chemotherapy, will take place at the Kongresszentrum-Hofburg, Vienna, Austria from August 28 to September 2, 1983. The scientific program will consist of main lectures (without parallel sessions), symposia, round table sessions, and free papers with posters. The program will include antimicrobial as well as anticancer topics. Abstracts (4 pages) will have to be submitted ready for print on an official abstract form to permit the possibility of prepublication. The deadline for submission of abstracts is May 1, 1983. Errata

The following errors occurred in the September 1981 article by F.
