**Matthew Bunn** is Associate Professor of Public Policy at the Harvard Kennedy School and a former adviser in the White House Office of Science and Technology Policy. He is the author, most recently, of *Securing the Bomb 2008* (2008).

**Paul Doty**, a Fellow of the American Academy since 1951, is Founding Director Emeritus of the Belfer Center for Science and International Affairs at the Harvard Kennedy School, Professor Emeritus of Molecular Biology and Public Policy at Harvard University, and Founding Chairman of the American Academy's Committee on International Security Studies, which carried out extensive dialogues with Soviet scientists during the Cold War.

**Harold A. Feiveson** is Senior Research Policy Scientist and Lecturer in Public and International Affairs at the Woodrow Wilson School of Public and International Affairs at Princeton University. He edited the book *The Nuclear Turning Point: A Blueprint for Deep Cuts and De-Alerting of Nuclear Weapons* (1999). He is Editor of the journal *Science & Global Security*.

**Alexander Glaser** is Assistant Professor at the Woodrow Wilson School of Public and International Affairs and in the Department of Mechanical and Aerospace Engineering at Princeton University. He is a participant in the University's Program on Science and Global Security and works with the International Panel on Fissile Materials, which publishes the annual *Global Fissile Material Report*.

**José Goldemberg** was, most recently, Secretary for the Environment of the State of São Paulo, Brazil. Previously he was a Professor of Physics at the University of São Paulo, and also served the Brazilian government in several roles, including Secretary of State for Science and Technology; interim Secretary of the Environment; and Minister of Education. His books include *Energy, Environment, and Development* (1996) and the edited volume *World Energy Assessment: Energy and the Challenge of Sustainability* (2000). In 2008 he received the Blue Planet Prize of the Asahi Glass Foundation in Japan.

**Paul L. Joskow**, a Fellow of the American Academy since 1991, is President of the Alfred P. Sloan Foundation and Elizabeth and James Killian Professor of Economics and Management at the Massachusetts Institute of Technology. His books include *Markets for Clean Air: The U.S. Acid Rain Program* (with A. Denny Ellerman et al., 2000), *Markets for Power: An Analysis of Electric Utility Deregulation* (with Richard Schmalensee, 1983), and *Electric Power in the United States: Models and Policy Analysis* (with Martin L. Baughman and Dilip P. Kamat, 1979). He also coedited *Empirical Industrial Organization* (with Michael Waterson, 2004).

**Anne Lauvergeon** is Chief Executive Officer of AREVA. She began her career in the industry before serving as Deputy Chief of Staff of French President Mitterrand. She was Senior Executive Vice President and member of the Executive Committee of Alcatel Telecom before joining AREVA in 1999.

**Richard K. Lester** is Founding Director of the Industrial Performance Center and Professor of Nuclear Science and Engineering at the Massachusetts Institute of Technology. His books include *Making Technology Work: Applications in Energy and the Environment* (with John Deutch, 2004), *Innovation: The Missing Dimension* (with Michael J. Piore, 2004), and *The Productive Edge: How U.S. Industries are Pointing the Way to a New Era of Economic Growth* (1998).

**Sverre Lodgaard** is Senior Research Fellow at the Norwegian Institute of International Affairs, where he served as Director from 1997 – 2007. Previously he was Director of the UN Institute for Disarmament Research (1992 – 1996) and Director of the International Peace Research Institute in Oslo (1987 – 1992). He is a member of the Executive Committee of the Pugwash Conferences on Science and World Affairs and of the Norwegian Government's Advisory Board on Security and Disarmament Affairs.

**Richard A. Meserve**, a Fellow of the American Academy since 1994 and a member of the Academy's Council and Trust, is President of the Carnegie Institution for Science and Senior of Counsel at Covington & Burling LLP. He is former Chairman of the U.S. Nuclear Regulatory Commission (NRC) and currently serves as Chairman of the International Nuclear Safety Group (INSAG), chartered by the International Atomic Energy Agency (IAEA).

**Steven E. Miller**, a Fellow of the American Academy since 2006, is Director of the International Security Program at the Belfer Center for Science and International Affairs at the Harvard Kennedy School. He is Cochair of the U.S. Pugwash Committee, a member of the Council of International Pugwash, a member of the Advisory Committee of the Stockholm International Peace Research Institute, and Editor-in-Chief of the quarterly journal *International Security*. He is Codirector of the American Academy's Initiative on the Global Nuclear Future. His many books include the co-edited volume *Going Nuclear: Nuclear Proliferation and International Security in the 21st Century* (forthcoming, 2010).

**Sam Nunn**, a Fellow of the American Academy since 1997, is Cochairman and Chief Executive Officer of the Nuclear Threat Initiative and Distinguished Professor at the Sam Nunn School of International Affairs at the Georgia Institute of Technology. He served as a U.S. Senator from Georgia from 1972 – 1996, and was Chairman of the Senate Armed Services Committee. Previously he was a Georgia State Senator from 1968 – 1972.

**John E. Parsons** is Executive Director of the MIT Center for Energy and Environmental Policy Research and the MIT Joint Program on the Science and Policy of Global Change; he is also a Senior Lecturer in the MIT Sloan School of Manage-

**Robert Rosner**, a Fellow of the American Academy since 2001, is the William E. Wrather Distinguished Service Professor in the Departments of Astronomy & Astrophysics and Physics at the University of Chicago. Previously he served as President of UChicago Argonne, LLC, and Director of Argonne National Laboratory. He recently coedited *The Solar Tachocline* (with David W. Hughes and Nigel O. Weiss, 2007).

**John W. Rowe**, a Fellow of the American Academy since 2009, is Chairman and Chief Executive Officer of the Exelon Corporation. He serves on the Board and Executive Committee of the Nuclear Energy Institute and is Cochairman of the National Commission on Energy Policy.

**Scott D. Sagan**, a Fellow of the American Academy since 2008, is Professor of Political Science and Codirector of the Center for International Security and Cooperation at Stanford University. He is Codirector of the American Academy’s Initiative on the Global Nuclear Future. His books include *The Spread of Nuclear Weapons: A Debate Renewed* (with Kenneth N. **Thomas C. Schelling**, a Fellow of the American Academy since 1967, is Distinguished University Professor Emeritus in the School of Public Policy at the University of Maryland. His books include *Strategies of Commitment and Other Essays* (2006), *Choice and Consequence* (1984), and *Strategy and Arms Control* (with Morton H. Halperin, 1961).

**Robert H. Socolow** is Professor of Mechanical and Aerospace Engineering and Codirector of the Carbon Mitigation Initiative at Princeton University.
