

Kriti Bhalla is an assistant professor at the School of Architecture, Ramaiah Institute of Technology, Bangalore. She pursued her Bachelor of Architecture from Dehradun Institute of Technology and has been working on humanitarian projects with a deep focus on inclusive and participatory design. Her approach to addressing socio-economic and sustainability issues in design is embedded in a democratic, pro-poor and women-empowerment context. She has been teaching sustainable design, architectural design, building construction, and systems thinking courses for the past five years.

His studies include: German philology, political science, philosophy, and theology in Göttingen, Regensburg, and Bamberg (Doctoral dissertation: “[*History*] as a Term,” Göttingen 1982; thesis of his postdoctoral lecturing qualification: “Poetry, justice, and freedom. The life and works of Sebastian Brant,” Bamberg 1988).” He was appointed Professor of Rhetoric in Tübingen in 1991; Dean of the Tübingen Faculty of Modern Philology 2004–2009; and since 2018, Senior Professor. His research has focused on the history of rhetoric, theory of rhetoric, rhetorical semiotics, media rhetoric, textual rhetoric, rhetoric of images, poetics and aesthetics, Renaissance studies, German language and literature.
